**Running Order and Class Information**

***Driving Directions to Lake Tye Park – Monroe, WA***

**From SR 203 (Duvall)** Drive north on SR 203 to Hwy 2. Take a left on Hwy 2 towards Everett for about 2 miles to Freylands Blvd. Turn left (south) onto Freylands and drive about .7 miles. The park is on the right (east) side of the road.

**From Eastbound Hwy 2:** From Hwy 2 out of Snohomish/Everett, drive towards Monroe. Just before entering Monroe (before the airport and Evergreen State Fairgrounds), turn right onto Freylands Blvd. Drive south about .7 miles to the park.

**Judges:** **Dan Butcher and Kurt Matushek**

**Height Order:** **All Classes:** Friday/Saturday Tall to Small, Sunday - Small to Tall

**Height Cards:** If you have not been measured or shown a height card, you must do so before you run. The gate sheets will be highlighted to indicate if you need to have your dog measured or show its card. We are scheduled to have an official measurer at the show. Make sure to give yourself plenty of time to get your dog(s) measured before you run.

**Judging Start Time:** Friday 2PM, Weekend 9:00 AM (checkin 1 hour before, walkthrough ½ hour before).

**Class Schedule:** **Friday** - Exc Std, Exc Jww. – rings alternate  
**Weekend – Ring1:** Exc Std, Opn Std, Nov Std. **Ring2:** Opn Jww, Nov Jww, Exc Jww.  
Weekend, rings will run at the same time.

**Walkthroughs:** **Open and Novice** – There will be a single, timed, walkthrough for each class.  
**Excellent** – We will have split walk-thrus. Friday 4/8/12/16 & 20/24/26.  
Weekend 4/8/12, 16, 20, 24/26.
