DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes

ONLINE ENTRIES: This trial does accept online entries through R2Agility.

(WWW.r2agilityonline.com). During the first 48 hours after opening, the initial limit of entries will be designated as follows: Online entries 100; Paper entries 250. If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either the online or paper limits accordingly. No hand deliveries will be accepted in the first twenty-four hours following the opening date and time.

MEASURING and HEIGHT CARD INFORMATION

All dogs competing in agility must possess an official AKC Jump Height Card. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog measured by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

When filling out the entry form, there is a section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*.

Our Judge is NOT a VMO.

ENTERING A MIXTURE OF REGULAR AND PREFERRED CLASSES WITHIN THE SAME TRIAL WEEKEND – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

ENTERING FOR EXHIBITION ONLY (FEO)

FEO will allow exhibitors to work with their dogs in a trial environment. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).

FIX AND GO ON

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Course maps will be posted, and exhibitor copies will be emailed the night before..

Judge's briefing will occur prior to each class except excellent- masters will not have briefings. Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Injured handlers may walk with their substitute handler. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

MOVE-UPS

Move-ups as a result of titles earned after entries close must be submitted in writing or email so that Heather (Trial Secretary) receives them by 6:00 PM PDT on Monday, May 26, 2025. Include dog's call name, owner's name, class you are moving from, and class you are moving to (replying to your final CONFIRMATION EMAIL is an ideal way to complete a move-up). If you do not receive an acknowledgement of your move-up request within 24 hours of sending, please contact Heather to make sure that it was received. No phone move ups accepted. Day-to-day move-ups will be accepted at the trial.

The Regulations now allow exhibitors who have entered a class for which the dog or handler is not eligible to change their entry to the class for which they are eligible, but the request for such a change must be in writing and must be submitted to the Trial Secretary at least 30 minutes prior to the start of the Trial.

Move-ups for Saturday and Sunday must be submitted in writing no later than 30 minutes after the conclusion of the last class on Friday and/or Saturday. For allowed changes from Novice A to Novice B, refer to Chapter 1, Section 21 of the Regulations for Agility Trials.

SAFETY, BEHAVIOR AND LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Greater Spokane Shetland Sheepdog Club, the Trial Secretary and Spokane County Fair and Expo and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The GSSSC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the GSSSC or any official thereof.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

DO NOT LEAVE ANIMALS UNATTENDED IN VEHICLES. The club will not be responsible for damage to vehicles resulting from the rescue of animals in distress.

ndlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height vision for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular mp height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may** t compete in a jump height division higher or lower than their proper height division.

dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, at measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to ve their dog(s) measured prior to running.

ogs listed in the AKC Canine Partnerssm program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs ould be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
